Attention for results / Performance /Outcomes of education grows

- positive consequences of education
- the cost of education for the taxpayer
- the cost of education for students and parents
- media-attention for "failures" and "mistakes"
- rankings, performance based-funding, TEF

Leads to: better quality, trustworthy QA, reliable information



Internationalisation is vital

- personal growth and development
- employers value this experience
- shortages on labour market
- improvement of quality
- growing request for education in parts of the world

Leads to: competition, rethinking of the role of internationalisation



Enormous development of professions

- technological developments
- IT
- growing markets and competition
- better relationship between research and development
- entrepreneurial shift towards SME's and starters
- universities as "developers"

Leads to: more attention for skills, attitude, entrepreneurship, LLL



Education is dynamic and has to change constantly

- "professionalisation of education" is necessary
- demands are higher
- teamwork instead of splendid isolation
- growth in student numbers
- growing diversity of students
- from "ex cathedra" to "blended learning" and "gaming"

Leads to: willingness and eagerness to be responsive



QA develops and has to follow

- shift from program-level to institutional level
- innovations in teaching and learning
- diversity in learning during professional life
- from control to culture?
- open market for QA-agencies?
- role of EQAR and the Register

Leads to: growing diversity in systems and reliability



The functions of education

- knowledge
- skills: both basic professional and generic
- personal development

Leads to: growing complexity



Good education needs communication

- universities have to speak out about importance and structures
- teachers and research, both basic and applied
- teachers and students: recognition of "talents" and evaluation
- teachers and the professional fields
- educational teams, groups, collective responsibility

Leads to: institutional policy, "professionalisation", responsiveness



Quality culture is ideal

- teaching is important and has to be acknowledged
- staff has to be self-critical
- staff is used to (internal) peer review
- evaluations by students and labour market are taken seriously
- staff is open towards "eyes from outside", benchmarks
- clarity about goals, objectives and learning outcomes

Leads to: permanent dialogue with environment, but.....



Life is not that easy !

- need for quality assurance
- performance indicators
- too many tasks and obligations: QA can not solve everything!
- narratives
- unavoidable level of control and bureaucracy
- keep an eye on the program!
- how to be supportive?

Leads to: "QA is here to stay!"

Need for cooperation and communication

- results have to be published
- universities need trust of and in society
- stakeholders are extremely important for support
- societal demands and challenges deserve responses from universities
- but risk of overload!

Leads to: cooperation and networks



Risks

- control instead of enhancement
- fatigue with academics and students
- overload of topics
- large and expanding caste of QA-staff
- institutional reviews might lead to lack of attention for programmes
- fear to invest in new and creative "experiments"



Conclusions

- QA is here to stay, whether as control or as culture
- education is more important than ever
- revival of the importance of teaching
- societal demands are piling up
- new methods of cooperation via networks
- stay internationalists!
- find ways to emphasise the need for enhancement
